

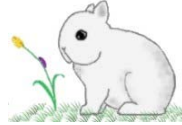

Submit entries to the show secretary. Breed class entry fees are \$3.00 per animal by mail. NO phone or Email entries, Fur entries are \$1.50. Mailed entries must be postmarked by May 8th 2010. Late entries mailed after May 8th are \$4.00 per animal. Day of show entries are \$5.00 per animal. Changes can be made up to 8am Saturday May 15th. Ear changes same class \$1.00 per animal. Class changes are \$5.00 per animal.

No refunds will be given for scratched entries. **NO COMMENT CARD SHOW**

All rabbits must be permanently and legibly tattooed. This is a carry case show. All carriers must have leak proof bottoms. Judging will begin at 8:00 AM sharp. All official ARBA show rules will be in effect. Animals entered in fur class must also be entered in breed class. Exhibitors are responsible for carrying their own animals to the table. The show superintendent may remove any animal showing signs of illness from the show room. Crazy 8's reserves the right to add, cancel, or substitute judges, as necessary. Crazy 8's is not responsible for any losses. Filing an entry indicates acceptance of these rules. Crazy 8 Rabbit Club reserves the right to refuse entries from exhibitors placing an entry from all locations within 150 miles of a confirmed outbreak of RHD/VHD/RCV within the past 60 days of the entry
